1 The Motion for Attorneys' Fees, Costs, and Service Award came before this Court on
2 August 24, 2020. The Court, having considered the Settlement Agreement; Plaintiff's Motion for
3 Attorneys' Fees, Costs and Service Award; the points and authorities and declarations in support
4 thereof as well as the arguments of counsel; and good cause appearing, HEREBY ORDERS THE
5 FOLLOWING:

6 1. The Court, for purposes of this Order, adopts the terms and definitions set forth in
7 the Settlement Agreement, unless otherwise specifically defined herein.

8 2. The Court awards \$337,453.41 in attorneys' fees to class counsel Pearson, Simon
9 & Warshaw, LLP and Perona, Langer, Beck, Serbin and Harrison ("Class Counsel"). The Court
10 finds Class Counsel's lodestar, based on their historical hourly rates, is \$1,470,180.50. The Court
11 finds that this lodestar amount is reasonable based upon the amount of work performed by Class
12 Counsel. In light of the novelty and difficulty of this action; Class Counsel's skill and effort in
13 dealing with the complex issues presented by this case; and the substantial benefit obtained for the
14 Class, the Court finds that Class Counsel is entitled to the requested award of attorneys' fees in
15 this case of \$337,453.41. This award represents a "negative" multiplier of 0.257.

16 3. The Court also finds that Class Counsel have incurred \$140,046.59 in litigation
17 costs. All of these costs were reasonably incurred in the ordinary course of prosecuting this case
18 and necessary given the complex nature and scope of the case. The Court finds that Class Counsel
19 are entitled to be reimbursed for these costs.

20 4. The Court further approves an incentive award of \$7,500.00 to the class
21 representative, Plaintiff Tami Trepte. This incentive award is justified by: (1) the risks Plaintiff
22 faced in bringing this lawsuit, financial and otherwise; (2) the amount of time and effort spent on
23 this case by Plaintiff; (3) the benefits Plaintiff helped obtain for the Class Members under the
24 Settlement Agreement; and (4) agreeing to a general release with a Civil Code § 1542 waiver.


